Job Description:

As Head of Research, you will be expected to contribute to the facilitation and development of partnerships with various stakeholders across the EU for the purpose of international cooperation in projects, consortiums, and networks. You should also be familiar with the think-tank and policy environment in Czechia/CEE region and on the EU level, leverage your previous experience and networks and be able to support the impact of our research on policymaking.
