On Thursday, 13 April, a presentation of the results of public opinion and a discussion entitled **"Migration and Climate in the Czech Republic after a Year of War"** took place. The results of the first public opinion poll in the Czech Republic, conducted as part of the **ReviveEU** project, on the topics of migration, climate change and attitudes towards the EU were presented. The **STEM agency** participated in the research and its representatives commented on the most interesting results of this part of the project, including some findings from the same survey conducted in other V4 countries.

As the anniversary of the Schuman Declaration approaches, we would like to cordially invite you to **Europe Day 2023**. On this occasion, a **special tram stop "Evropská"** will be built on the Legion Bridge.
